Dear Parents and Guardians,

While it is hard to believe, registration for the 24-25 school year is upon us. Please fill out the attached registration and turn in by March 1, 2024 along with the registration fee of \$150.00 for K-8 or \$75 for Preschool. Registration for the 2024-25 school year will not be accepted however, until all past due fees are paid in full-this includes aftercare and registration fees from 2023-2024.

As part of St Albert the Great school's future planning, the school's goal is to be self-sustaining. Therefore changes will be made to the 2024-25 school year in regard to tuition. We are taking the advice of the Archdiocese of Cincinnati and will no longer offer multi-child discounts, parishioner discounts and military discounts. There have been many past years where the parish has funded the school losses with church donations above and beyond the discounts listed above.

The new K- 8 tuition rate for St. Albert the Great School is \$6,500.00. (This brings us closer to the actual amount to educate each student.) There will be a St. Albert discount of \$344.00 per K- 8 student to reduce the total tuition to \$6,166.00. With ALL families (who applied) receiving EdChoice funding, and with more than 88% of our families receiving the FULL EdChoice Scholarship (Ohio EdChoice Scholarships will cover the entire \$6166 for those families who qualify) St. Albert the Great will be using any additional funds that we may have available to help those families who are hit the hardest by this increase in tuition. If you would like to apply for financial aid over and above what you are receiving from EdChoice, please reach out to the school office to schedule an appointment. However, to qualify for aid from St. Albert the Great you must first apply for the Ohio EdChoice scholarship. This will ensure that we are able to help as many people as possible. The Preschool tuition rates remain unchanged and can be found on a separate sheet included with this letter.

Every family must set up a FACTS account even if you are receiving the full EdChoice scholarship.

We will introduce incidental billing through FACTS in 2024-25. Related to this new feature, it is

mandatory for all families to be enrolled in Auto Pay through FACTS, this is how fees, field trips costs,

and afterschool care fees will be collected in the 2024-25 school year. This must be completed by

August 1, 2024 and must NOT be cancelled at any time during the year. Should we go into your account

to bill for something and your Auto Pay has been cancelled you will incur a \$100 fee.

Tuition (if owed) will be collected in one of three ways and all will be done through your FACTS

account - you may not make a payment directly to the school:

1. Full pay of the amount not covered by the EdChoice Scholarship on or before July 31, 2024 - no

additional fee is incurred with this option.

2. 50% of tuition amount paid on August 15, 2024 with the remaining balance paid on or before

January 15, 2025 - no additional fee is incurred with this option.

3. Bi- weekly (beginning in July 2024) or monthly (August 2024-May 2025) payment plans. There is

an additional fee charged by FACTS for this option.

us with your child's education and look forward to watching them grow over the upcoming school year.
